Dear Providers:

This notification describes important information regarding changes to the existing Atypical Antipsychotic Prior Authorization process, which went into effect on January 18, 2005. **Effective February 10, 2005**, Providers will be required to submit an ICD-9 code when submitting Atypical Antipsychotic claims requiring prior authorization, to Medicaid. The ICD-9 code will be submitted in Field 424-DO. Use the attached list of ICD-9 codes as a reference tool. The ICD-9 codes must be entered **exactly** as seen on the list. If a decimal is shown on the list then a decimal must be used when submitting the claim. For claims processing questions, please call the **Provider help Desk for assistance at 800-432-7940. Requests for non-preferred agents will require completed fax request to be fax to the First Health Services Prior Authorization line at FAX # 800-365-8835.**

**REMINDERS:**

- Effective 1-18-05, patients currently on atypical antipsychotic monotherapy or dual therapy may continue current drug regimen without needing prior authorization.
- All prescriptions must contain appropriate diagnoses. The prescriber must write either the appropriate ICD-9 code or the diagnosis on the prescription. If the prescriber chooses not to do so, a prior authorization form must be completed with the ICD-9 code and diagnosis written on the PA form. The pharmacy provider will be required to submit an ICD-9 code when submitting a claim to Medicaid. The ICD-9 code will be submitted in Field 424-DO.
